Public perception of PLHIV stigma about HIV / AIDS is still negative, it means that people living with HIV feel that people still have a bad stigma against PLWHA. Less perceptions of community stigma about HIV / AIDS can affect the social life of PLWHA and the progression of the disease. The stigma of society towards people living with HIV makes them treated differently / discriminated by society. Stigma also hinder people living with HIV to conduct social activities for people living with HIV be shut down and tend to be willing to interact with family, friends and neighbors. PLWHA perceptions against social stigma about HIV / AIDS is known that only the age and education were associated significantly. Someone perceptions of them influenced by the attitude of the individual concerned to the object of perception, motives and desires unfulfilled that is within oneself, experiences and expectations. One's experience is related to one's age. The older the age of a person the more life experience. The older the age of people living with HIV, the perception of people living with HIV / AIDS to the stigma of people about HIV / AIDS more positive. This can be explained because the experience of life he lived in problems solved including in the stigma of society about HIV / AIDS. From this research it is found that most of respondent education level of higher education, middle and low have negative perception toward society stigma about HIV / AIDS. It can be explained that the perception of people living with HIV / AIDS on community stigma about HIV / AIDS is probably due to their lack of knowledge about HIV / AIDS transmission. Correct knowledge about HIV / AIDS is very influence emergence of stigma in society about HIV / AIDS and this is because they do not know how the mechanisms of transmission of HIV / AIDS.
