We would like to submit a new manuscript entitled “ANALYSIS OF TRADITIONAL HEALTH CARE IN THREE SUBDISTRICT HEALTH CENTERS IN WEST JAVA PROVINCE, INDONESIA 2018” for consideration by the Kesmas: National Public Health Journal.

We confirm that this work is original and has neither been published elsewhere nor currently under consideration for publication elsewhere.

In this paper, we report on the analysis of traditional health care and the hindering factors in its implementation at 3 subdistrict health centers: Ciomas, Ciawi and Caringin. The recommendations will serve as inputs for betterment. This is significant because of several reasons as follow: 1) after the launch of traditional health care by the Ministry of Health in 2011, never a review on how it is implemented at the health centers was done. The paper should be of interest to readers in the area of public health.

The National Strategic Development on Health MOH has set a target that by end of 2018, 60% of all health centers in Indonesia (total of 9656 from MOH Data 2014) should carry out traditional health care. Yet, so far there was no study on how far is traditional health care performed by the health centers, and this became the justification why this study was conducted. To know a glimpse about what is happening about traditional health care at the health center level, this study selected 3 health centers at Bogor district. The study is very much on one important public health area because it focuses on the delivering of traditional health care at the health center level (puskesmas) which is the first level of health facility for the community.
